## **REGULATION**

### **Art.1**

Each participant in the competition, **upon registration**, renounces to any representation rights, to any compensation for participation in the EVENT and authorizes the organization managed by the association M.A.R.W ELLOWS4 S.S.D a.r.l., on the occasion of the "MILANOGRANDBALL" sporting event of 25-25 JANUARY 2019 at the "Marriot Hotel" in Milan (MI), to acquire and use their image for EXHIBITIONS, COMPETITIONS, PUBLICATION ON THE INTERNET, PUBLICITY, ETC., FOR THE ONLY promotional and dissemination purposes authorized by current legislation, highlighting the excluded use in contexts that compromise personal dignity and decorum;

### **Art.2**

The organization declines all responsibility for damages to persons and / or things that may happen during the event, the same suffered and / or caused by people participating in the event, as well as any theft suffered inside and / or near the "Marriot Hotel";

### **Art.3**

Registration will be made exclusively through the website [www.milanograndball.it](http://www.milanograndball.it), in the dedicated areas provided with specific REGISTRATION MODULES with relative acceptance of the rules and contextual payment, which will take place through PAYPAL or CREDIT CARD

### **Art.4**

The notification of the registration will be received by the compiler at the e-mail address indicated in the ENTRY FORM **only after** having correctly completed the payment transaction, an email will be received at the same time also by the administrator of the ONLINE payment system, useful for the necessary feedback in case of any anomalies represented by the participants in the event;

### **Art.5**

The organization declines all responsibility and administrative reimbursement for data provided in the REGISTRATION FORM that have not been inserted correctly and / or intentionally false.

#### **Art.6**

At the time of accreditation, members must present themselves with a print of the receipt of registration, attached in the notification email in PDF format, produced by the system at the time of registration and a valid identity document.

#### **Art.7**

The Organization of the Competition will not take into account applications without the required documentation, nor applications received late by other means, and those without signatures required. **The registration fees are in no case reimbursable** as they are used for the organization, security of the participants and all the necessary protections in order to obtain the regular and smooth running of the event, meaning that the fees paid at the time of registration is not for profit;

The organization reserves the right to close registrations when the maximum number of participants is reached, even differently from the pre-established period and indicated by any information channel;
